## PRIVACY POLICY

A&G Foundation (“we,” “us,” or “our”) is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard information when you visit our website, donate to our organization, or otherwise interact with us. Please read this policy carefully. By using our website or services, you agree to the terms of this Privacy Policy.

### 1. Information We Collect

---

We may collect the following types of information:

**Personal Information You Provide:**

- Full name and contact details (email address, phone number, mailing address)
- Payment and billing information when you make a donation
- Communications you send us (emails, contact form submissions, feedback)
- Volunteer applications and program participation data

**Information Collected Automatically:**

- IP address and browser type
- Pages visited, time spent on pages, and referring website
- Cookies and similar tracking technologies

### 2. How We Use Your Information

---

We use the information we collect to:

- Process and acknowledge donations and issue tax receipts
- Communicate with you about our programs, events, and updates
- Respond to inquiries and provide support
- Improve our website and services
- Comply with legal obligations and maintain accurate records
- Send newsletters or fundraising appeals (with your consent)

### 3. How We Share Your Information

---

A&G Foundation does not sell, trade, or rent your personal information to third parties. We may share your information only in the following limited circumstances:

- Service Providers: Trusted vendors who assist us in operating our website, processing donations, or conducting outreach — subject to confidentiality agreements.
- Legal Requirements: If required by law, regulation, or court order.
- Protection of Rights: To protect the rights, safety, or property of A&G Foundation, our supporters, or the public.

## **4. Donor Privacy**

---

We deeply respect the generosity of our donors. Donor information is held in strict confidence. We will not share, sell, or exchange your name or personal information with any other organization. Donors who wish to remain anonymous may request that their name not appear in any public acknowledgment of their gift.

## **5. Cookies and Tracking Technologies**

---

Our website may use cookies — small data files stored on your device — to enhance your browsing experience and gather usage statistics. You may adjust your browser settings to refuse cookies; however, some features of our website may not function properly without them.

## **6. Data Security**

---

We implement reasonable administrative, technical, and physical safeguards to protect your personal information from unauthorized access, disclosure, alteration, or destruction. While we strive to protect your data, no method of electronic transmission or storage is 100% secure, and we cannot guarantee absolute security.

## **7. Third-Party Links**

---

Our website may contain links to external websites for informational purposes. A&G Foundation is not responsible for the privacy practices or content of those third-party sites. We encourage you to review the privacy policies of any site you visit.

## **8. Children's Privacy**

---

Our website is not directed at children under the age of 13, and we do not knowingly collect personal information from children. If we become aware that a child under 13 has provided us with personal information, we will promptly delete it.
